AUTHORIZATION FOR AUTOMATED CLEARINGHOUSE (ACH) PAYMENT

The undersigned, hereinafter called "Owner" is representing that they are the owners of an oil, gas and/or mineral interest that is currently paid by Prairie Gas Company of Oklahoma, LLC ("PGCO"). Owner is now authorizing PGCO to make ACH payments for their owned interest to the financial institution and Owner account as designated below.

Owner agrees that electing to participate in ACH payments will not amend any lease agreements between PGCO and Owner. This agreement simply allows for ACH payments in lieu of paper check payments.

Owner agrees to give at least thirty (30) days advance written notice of any change in the payment instructions shown below. Owner agrees that any changes to their mailing address will continue to be submitted in writing to PGCO. The ACH payment details will be delivered electronically to the Email Address below. Owner agrees that PGCO will not be held liable for any interest or other claim arising as the result of Owner's failure to provide written notice of any payment instruction changes. Owner also releases and agrees to indemnify and hold PGCO harmless for any loss, claim, damage or interest incurred as the result of Owner's depository institution's failure to properly or promptly post any ACH payment and/or as a result of any error or omission in the payment instructions provided by or on behalf of Owner. Owner understands and agrees that PGCO will have up to sixty (60) days after receipt of the authorization form to process the ACH request.

Dear Interest Owner:

If you have not previously elected to do so, Prairie Gas Company of Oklahoma, LLC (“PGCO”) would like you to participate in our Direct Deposit program. This program is part of our continuing evaluation of our owner relations services that provides a benefit to our owners. Some benefits of direct deposit are the elimination of mailing delays, lost or stolen checks and receipt delays related to address changes.

The Direct Deposit program will allow our interest owners to receive an ACH to their designated financial institution (bank, credit union or savings and loan). The ACH will deposit the net cash value of your monthly payment into your designated account and will eliminate the need for a negotiable printed check. Instead, you will receive an ACH Revenue Remittance report. The ACH deposit will be posted to your account on or before the last business day of the month. The Direct Deposit program will not be changing any terms related to payments as stated in your lease or other agreements with PGCO.

Please read, sign and return the ACH authorization form included with this letter. It is important that the authorization signature be that of the actual interest owner that is listed on the checks you now receive from PGCO. If the ACH is to be deposited to an account that is not PGCO’s interest owner, we will need an additional authorization signature allowing the ACH deposit.

Please note that to ensure proper crediting of the ACH payments, PGCO requires that you include a voided check or provide a letter from your financial institution with the required ABA routing numbers and your account number. Prior to returning the signed ACH authorization agreement form, please verify with your financial institution that they can accept ACH payments.

Return the completed form with required documentation to the attention of Owner Relations at the address shown above. Should you need to submit a change of address, please go to our website at www.pgcollc.com to find the Change of Address Form under Mineral Owners and select Change of Ownership.
